# Distinguished Service Cross 105th Infantry Regiment





The Distinguished Service Cross is awarded to a person who, while serving in any capacity with the Army (or in the Air Force, before 1960), distinguishes themselves by extraordinary heroism not justifying the award of a Medal of Honor; while engaged in an action against an enemy of the United States; while engaged in military operations involving conflict with an opposing/foreign force; or while serving with friendly foreign forces engaged in an armed conflict against an opposing armed force in which the United States is not a belligerent party. The act or acts of heroism must have been so notable and have involved risk of life so extraordinary as to set the individual apart from their comrades.

The 105th Infantry regiment amassed a total of 47 Distinguished Service Crosses between the two World Wars. The vast majority were from World War One, most likely due to the fact that the Silver Star medal had not been in existence at that time (created by Congress in 1932). The Third Battalion Soldiers received the lion's share with 18. The majority of the actions took place in two locations. Ronssoy, France in the last week of September 1918 and St. Souplet, France in the third week of October, 1918.

### WORLD WAR ONE

#### ATKINS, MARVIN L.

First Lieutenant, U.S. Army

105th Infantry Regiment, 27th Division, A.E.F.

Date of Action: October 18, 1918

Citation:

The Distinguished Service Cross is presented to Marvin L. Atkins, First Lieutenant, U.S. Army, for extraordinary heroism in action near St. Souplet, France, October 18, 1918. Continuing in action after being gassed, Lieutenant Atkins displayed exceptional personal bravery when the advance of his platoon was checked by heavy machinegun fire, in seizing the gun of a wounded soldier and attacking a machine-gun, which he silenced and captured. Under the inspiration of this fearless act his company overcame several other machine-gun emplacements and reached the objective.

Citation:

The Distinguished Service Cross is presented to Stanley Bulkley, Captain, U.S. Army, for extraordinary heroism in action near Ronssoy, France, September 29, 1918. Commanding the 3d Battalion of his regiment, and having led them forward to a position covering the left flank of the division, Captain Bulkley discovered a small unit of another battalion located in a shell hole some distance in advance of his position. Finding this unit entirely surrounded by the enemy and in imminent danger of total annihilation, Captain Bulkley, though suffering from a severe head wound, rushed forward to their assistance, firing a Lewis gun, breaking the enemy's attack, and killing and wounding several of the machine gunners. This action was in full view of the enemy and performed with utter disregard of heavy enemy machine-gun and rifle fire, and served as an inspiration to the members of the American fighting forces engaged in that operation.

The Distinguished Service Cross is presented to Russell P. Byington, Private First Class, U.S. Army, for extraordinary heroism in action east of Ronssoy, France, September 29, 1918. During the operations against the Hindenburg line, he was wounded early in the action but continued to advance with his company, and declined to go to the rear for medical treatment. Later in the engagement he was killed by a machine-gun bullet. His gallantry and bravery and absolute disregard for his personal safety was a splendid example to all ranks.

He completed this mission and returned for another comrade, who was lying wounded still farther forward. He also successfully brought this man to safety. That evening he led a detail through the murderous fire to replenish the supply of hand grenades. While returning to the lines he was seriously wounded when the box which he was carrying exploded.

In the face of concentrated fire from hostile machine guns, Private Cohoon, together with Corporal George D. Caswell, made his way over rough and broken terrain under observation of the enemy, rescued a severely wounded comrade, carried him to a place of safety, and returned to a point still farther in advance of his own lines and carried another member of his company to shelter. This action, showing indomitable bravery and devotion to duty, undoubtedly saved the lives of the wounded men and set a splendid example of courage and self-sacrifice to other members of the command.

During the operations against the Hindenburg line Lieutenant Elkins, with three sergeants, occupied an outpost position in advance of the line, which was attacked by a superior force of the enemy. He so directed his small detachment that he succeeded in repulsing the attack, killing ten Germans, capturing five, and putting the rest of the enemy to flight. The bravery and determination displayed by this group were an inspiration to all who witnessed them.

soldier attacked an enemy dugout, killing two of the enemy and taking one prisoner. This courageous act set a splendid

example to all.

The Distinguished Service Cross is posthumously presented to James A. Hamilton, First Sergeant, U.S. Army, for extraordinary heroism in action near Ronssoy, France, September 27, 1918. First Sergeant Hamilton rallied his company after it had become disorganized under a machine-gun barrage and all the officers were killed or wounded. He led his men forward in an effective attack, and was shortly afterwards killed while moving along his line.

During the advance of his company into the town, Private Keene, with utter disregard of his own personal danger, pursued several of the enemy into a house, and, single-handed, captured ten of them as they were in the act of setting up a machine-gun. On the following morning, October 18, 1918, near the town of Mazinghein, when the advance of the battalion had been temporarily halted by heavy enemy fire, Private Keene voluntarily carried a message for reinforcements to battalion headquarters through intense shell and machine-gun fire and returned with the necessary reinforcements, thereby enabling the battalion to continue its advance.

While patrolling alone in advance of the line, Sergeant Kenny discovered a German officer directing a detachment in establishing machine-gun posts. He immediately opened fire, killing one and forcing the others to surrender. Later, reinforced by the remainder of his squad, Sergeant Kenny captured 34 of the enemy, including seven officers.

He continued his aid until he himself was severely wounded while attempting to obtain stretchers with which to move the more serious cases. His remarkable courage and devotion to his comrades inspired every man of his command.

The bravery and determination displayed by this group was an inspiration to all who witnessed it.

When sent out as a scout with a small patrol consisting of an officer and two men, Private Klinge courageously went ahead alone, killed two enemy scouts, whom he encountered, and drove the gunners away from two machine-guns. When the patrol came up the capture of the guns was completed with their assistance.

When the advance of his company was checked by concentrated machine-gun and rifle fire Sergeant Lee advanced alone, sought out enemy machine-gun nests, and by the use of hand grenades and with complete disregard for his own safety, killed and wounded members of enemy machine-gun crews, causing them to abandon the guns, and thus permitting the Infantry to again advance. Sergeant Lee's courage and devotion to duty raised the morale of his company to a high pitch.

After his battalion had been compelled to withdraw because of enfilading fire, Lieutenant Lisa displayed marked bravery in going forward and attending wounded men whose evacuation was impossible because of the intense fire.

Having been trapped in a shell hole with nine other men 50 yards in front of the line, Corporal Lynch crawled back to his company's position through heavy enemy machine-gun fire and reported their predicament. He then organized a bombing party, led it against the hostile machine gun and put it out of action, thereby enabling his men to return safely to our line.

The Distinguished Service Cross is presented to Leon R. Matson, Sergeant, U.S. Army, for extraordinary heroism in action near Ronssoy, France, September 27 & 29, 1918. On the morning of September 27, after all the officers and most of the sergeants of his company had been killed, Sergeant Matson took command and led the company into effective combat, making repeated reconnaissance in front of the line under severe machine-gun fire. On September 29 he led his men forward, capturing an important knoll, and held it with a small number of men. Finding the ammunition and food depleted, he led a detail through the heavy machine-gun fire, bringing back both food and ammunition.

After having been wounded in the head and suffering great pain, Lieutenant Matthews coolly and efficiently made dispositions for the security of his guns and safety of his men and the evacuation of the wounded. Later at a dressing station, though bleeding profusely, he refused surgical attention until other wounded men of his platoon had been cared for.

When his company was occupying a front -line position and suffering heavy losses from a near-by enemy sniper, Lieutenant Merz, locating the sniper, left his shelter and at great personal danger courageously advanced and succeeded in destroying the sniper and his nest with hand grenades.

Organizing his units just before entering the town, Captain Potter advanced under heavy machine-gun and rifle fire, captured the town with numerous prisoners, and from his new position silenced several enemy machine guns. On the morning of October 18, while he was in command of the 105th Infantry Battalion he advanced about 300 yards and was stopped by intense machine-gun fire. His coolness and complete indifference to danger inspired his men to further advance despite the heavy machine-gun fire from the strongly held position in a sunken road immediately in the battalion's front, which position was promptly captured, together with numerous prisoners and machine guns.

During the attack on the Hindenburg line Private Ratchick displayed unusual coolness and bravery when on two occasions he voluntarily carried wounded comrades to a dressing station about 1,500 yards distant and each time returned to his company over a road that was being swept by heavy artillery and machine-gun fire. By his utter disregard of personal danger, Private Ratchick set an example which was of the utmost value to his company then and throughout all of its subsequent engagements.

On September 29, Sergeant Scott assisted in carrying a wounded soldier through an exposed area under heavy fire to a place of safety.
