## Commander's Message

Greetings,

The past couple of months have been ones of great emotional highs and lows. The soldiers of the 27th Brigade, deployed to Iraq this past February, have all been in our prayers and thoughts. In the past month we experienced the great loss of Private First Class Nathan Brown on Easter Sunday, and the thrilling recovery of an American hostage by 27th Brigade Soldiers. In fact, both of these actions were by the same rifle company, Charlie Company 2nd Battalion 108th Infantry.



I had the somber privilege of attending the services for Private First Class Nathan Brown. The mass for Nathan was somber and his friends and family spoke of how they would miss him. Glens Falls is a small community and there were many well wis hers outside the church holding flags and notes of hope.

Nathan was buried in Saratoga National Cemetery, in Schuylerville. It is about 20 miles from the church to the cemetery. All along the route there were people lining both sides of the road. A rough estimate is that between 7 and 8 thousand people took 5 minutes out of their day to honor Nathan as the hearse passed. At each of the 6 towns between Glens Falls and Schuylerville, there was an American Legion or VFW color guard on the side of the road, Fire trucks with lights flashing. Former service members were saluting, folks with their hands or hard hats over their hearts, and children holding flags, A crane at a construction site had an American flag at half mast on its cable.

As we drove past one diner, they had changed their marquis to read Nathan Brown, An American, A Soldier, A Hero. Nathan sacrificed his life so others could be free, continuing a 27th Division tradition of ending oppression and making the world a better place with the sweat and blood of young and courageous men and women.

On May third, the members of C Company, led by Capt. George Rodriguez, recovered an American contractor, Thomas Hamill, who was being held hostage in Iraq.

In this issue of the Gallivanter, you will see the briefing that Lt. Joseph Merrill and Sgt. 1st Class Mark Forbes gave to the press at the Coalition Provisional Authority Headquarters. Later that week.

The plans for the reunion are being finalized, and with the approval of the executive committee we will be able to share them with you Stay tuned for the details, I am confident this will be the best yet.

The details for the reunion are also in this issue. Please make your reservations soon to ensure you will not miss any of the fun.

#### **Bob Wartonick**

The USS Constitution (Old Ironsides) as a combat vessel carried 48,600 gallons of fresh (remember the figure) water for her crew of 475 officers and men. This was sufficient to last 6 months of sustained operations at sea. She carried no evaporators (fresh water distillers).

However, let it be noted that according to her log. "On July 27, 1798, the USS Constitution sailed from Boston with a full compliment of 475 officers and men, 48,600 gallons of fresh water, 7,400 cannon shot, 11,600 pounds of black powder and 79,400 gallons of rum".

Her mission: "To destroy and harass English shipping".

Making Jamaica on 6 October, she took on 826 pounds of flour and 68,300 gallons of rum. Then she headed for the Azores, arriving there 12 November. She provisioned with 550 pounds of beef and 64,300 gallons of Portuguese wine. On 18 November,

she set sail for England.

In the ensuing days she defeated 5 British men-of-war and captured and scuttled 12 English merchantmen, salvaging only the rum aboard each.

By 26 January, her powder and shot were exhausted. Nevertheless, and though unarmed, she made a night raid up the Firth of Clyde in Scotland. Her landing party captured a whiskey distillery and transferred 40,000 gallons of single malt scotch aboard by dawn. Then she headed home.

The USS Constitution arrived in Boston on 20 February 1799, with no cannon shot, no food, no powder, no rum, no wine, no whiskey and 38,600 gallons of stagnant water.

It was not a nine to five job, where I took time off to take the daily cash receipts to the bank. I ask you to go with me ... as I went the other day ... to a Veterans Hospital and look those men - with their mangled bodies - in the eye, and tell THEM they didn't hold a You go with me to the Space Program at NASA and go, as I have gone, to the widows and orphans of Ed White, Gus Grissom and Roger Chaffee ... and you look those kids in the eye and tell them that their DADS didn't hold a job. You go with me on Memorial Day and you stand in Arlington National Cemetery, where I have more friends buried than I'd like to remember, and you watch those waving flags. You stand there, and you think about this Nation, and you tell ME that those people didn't have a job? I'll tell vou, Howard Metzenbaum, you should be on your knees every

day of your life thanking God that there were some men - SOME MEN - who held a REAL job. And they required a dedication to a purpose - and a love of country and a dedication to duty - that was more important than life itself. And their self-sacrifice is what made this country possible. I HAVE held a job, Howard! --- What about you?"


For those who don't remember - During WWII, Howard Metzenbaum was an attorney representing the Communist Party in the USA. Now he is a Senator!

The September 2003 article "Battling For Saipan" brought back many memories and questions that have bothered me for many years.

After arriving at Schofield in May, 1943, I was assigned to the 27th Division, 102nd Engineers (c), Company A and was stationed in Kailua, Hawaii for a year prior to Saipan. During the Saipan campaign, we were assigned to the 2nd Battalion of the 105 Infantry.

I remember vividly that Banzai attack. The day before while the 2nd Battalion was preparing to dig in for the night along the beach, I and others were transferred from the 2nd to the 3rd and moved up on the hill overlooking the Tanapag Plain and

beach. I was assigned to help attend a machine gun overlooking the valley. The name of the hill I had forgotten. I know it was a CP and I remember during the day of the attack on the 7th of July a couple of Japanese soldiers were being questioned. It could have been Capt. Rohner post, but not sure. During the early morning of July 7th and into the night we fought off Japanese soldiers coming up the hill, some with bayonets and hand grenades only.

If anyone remembers me or can give additional information and any citations that should have been awarded, please contact me. In 1992 I attended the 102nd-152nd Engineers (c) BN Vet Assn in Las Vegas, Nevada. Sgt. Irv Ziffer and others I knew where there

## **Taps**

#### Martin E. Nolan

Colonel Martin Nolan enlisted in the Army Reserve in 1938, when he was then teaching 7th and 8th grade Social Studies in the State of New York in 1941 he was commissioned as a Second Lieutenant of the Infantry and volunteered for active duty in August That began 31 of that year. years of active service, including combat in the Pacific Theater in WWII at Makin in the Gilbert Island, Saipan and Okinawa. He was the Intelligence Officer and later Executive Officer of the 15th Infantry Regiment of the 3rd Div in Korea from August 1950 until December 1951. New York guardsman remembered with full honors

By Kirstan Conley Associated Press GLENS FALLS, N.Y. — An

American flag and Rick Brown's face were reflected in the windows of St. Alphonsus Church here Tuesday.

Brown stared straight ahead as the flag was draped over the silver casket of his 21-year-old son, who was killed while serving in Iraq.

About 1,000 people waited inside the church to follow the fresh-faced New York Army National Guardsmen, who eventually would lead Nathan Brown's body along the banks of the Hudson River to his plot in the Saratoga National Cemetery.

Brown, who attended South Glens Falls High School, died April 11 when a rocket-propelled grenade hit his Humvee in Samarra, Iraq, about 60 miles north of Baghdad. The attack also injured friends from Brown's hometown who served with him in the Army National Guard's 2nd Battalion, 108th Infantry, based in Glens Falls.

Bishop Howard Hubbard of Albany noted how Brown's death

came on Easter Sunday, the same day people in the young soldier's hometown celebrated the resurrection of Christ. The Christian faith, Hubbard said, is one of paradox: death brings life and suffering brings glory.

Members of Brown's battalion carried his casket. Men in dress uniforms retired from battles dating back to World War II flushed as they strained to hold back tears.

Brown planned to get married and enroll in Adirondack Community College when he returned. Staff Sgt. Arthur Coon gave a eulogy, saying he was proud to recruit Brown. He said the military sent Brown a defective backpack, then a second one to replace it.

"He arrived to say his final goodbye and gave me the back-pack," Coon said. "It seemed like a simple gesture. He gave me the new one and kept the damaged one."

Coon said he wants people to remember Brown's generosity and positive attitude. He said a planned arsenal in Glens Falls should be named in Brown's honor.

Brown's friends, Robert Havens and Joe Nassivera, embraced after breaking down in tears as they tried to put in words what their friendship with Brown meant. Friends recalled Brown building forts, playing along the river and causing mischief.

#### Obrien/Baker Post

The O'Brien/Baker Post of the 27th Division Assn. is planning to dedicate a memorial the three members of the 105th Infantry Regiment who were awarded (posthumously) the MEDAL of HONOR for their actions on Saipan on 7 July 1944. They are Lt. Col William O'Brien, Capt. Ben Salomon and Sgt. Thomas Baker. They were all members of the 1st and 2nd Battalion 105th Regiment.

Capt. Salomon's award came on 1 May 2002 after many years of work and was presented by President Bush. A medical lab has been named after Capt Salomon at Ft. Benning and a memorial is in place at The Army Medical Corps at Ft Hood in Texas. O'Brien and Baker have a display in the Armory on Gilmore Rd. in Troy N.Y.

The ceremony was scheduled to take place at the New York State Military Museum and Veterans Research Center on Lake Ave, in Saratoga N.Y. on 7 July 2004 the 60th, anniversary of the Banzai Attack, but has been postponed due to construction delavs. The 1st and 2nd Battalions were awarded the Presidential Unit Citation for their performance on that day. 



is a platoon leader; and Sergeant First Class Mark Forbes [is] a platoon sergeant.

I'd like to start with a brief statement. At 1030 hours on Sunday, 2 May at a location 70 kilometers northwest of Baghdad, a patrol from Task Force 1-26 Infantry was conducting security operations when they approached -- they were approached by a man claiming to be an American. The man identified himself as Thomas Hamill, a Halliburton employee who had been taken hostage by anticoalition forces on April. Mr. Hamill had a gunshot wound to his right forearm. He appeared to be in overall good health, but he was rendered medical aid by the soldiers on the scene.

The soldiers, who were assigned to Charlie Company, 2nd Battalion, 108th Infantry, and task organized to my brigade combat team, are from the New York National Guard. They secured Mr. Hamill, who then led them to the house where he had been

held captive. The patrol conducted an immediate search of the house where Mr. Hamill was held, where they

detained two males and seized one AK-47 rifle. There were no U.S. or Iraqi casualties in this operation.

At approximately 1200 hours, the patrol called for medical evacuation and a medevac helicopter transported Mr. Hamill to the nearest medical treatment facility, just north of Tikrit. Mr. Hamill received -- was arrived -- correction, arrived at the medical facility at approximately 1315 hours, where he received expert medical treatment by U. S. Army health care personnel.

The soldiers of the 1st Infantry Division are proud that we were able to assist in securing Mr. Hamill's freedom. We are equally proud of the courage of all civilians and military that have chosen to make a difference in this mission in Iraq.

I speak for every soldier in the 1st Infantry Division in saying that we are extremely honored to have the professionals of the 2nd Battalion of the 108th Infantry fighting as part of our team. The unit was mobilized just eight months ago and now serve, as do all coalition forces, to eliminate the threat here in Iraq while simultaneously helping to provide a stable environment and set the conditions for Iraqi civil and military selfreliance. Due to the efforts of these great soldiers here, an American will return home to his family. Freedom is priceless.

Brown was buried with full military honors. Shots echoed across rolling green hills and cornfields as a seven-member rifle team fired its salute.

The soldier also received a special honor when members of the 3rd Battalion, 142nd Aviation Regiment of the New York Army National Guard flew five UH-60 Black Hawk helicopters from Albany International Airport to the service in a Missing Man Formation.

Maj. Gen. Thomas Maguire, a two-star general and the state's highest-ranking National Guard officer, presented the family with a Bronze Star, a Purple Heart and a New York State Medal of Valor. The state Senate approved a resolution honoring Brown's memory.

"What can I say and what can I do to mend the heartbreak of the family?" asked state Sen. Elizabeth Little of Warren County. "At a time when words seem very inadequate, I think the only thing we can do is through our presence and through our actions here today in this resolution and through our thoughts and prayers express our sorrow and sympathy to family and our gratitude."
