27th Brigade Kicks-off AT 2007

Nearly 2,000 members of the New York Army National Guard's 27th Infantry Brigade Combat Team and supporting units and personnel are on post to conduct an aqgressive Annual Training period that for many will stretch to three weeks.



Participating units include the Syracuse-based brigade headquarters, the Fighting 69th and 2nd Battalion 108th Infantry, the 2nd Squadron 101st Cavalry, the 258th Field Artillery the 27th Brigade Sustainment and the 427th Support Battalions. In anticipation of a future mission, dozens of new

Orion officers and enlisted Soldiers have and continue to be transferred in from the state headquarters, 106th Regional Training Institute, 42nd Infantry Division and 53rd Troop Command units.

"The 27th has entered an exciting new period as we prepare for an important future missions," said COL Brian Balfe, brigade commander. "We have much to accomplish over the next few weeks and every Soldier must be focused on preparing now for the challenges ahead. I am proud of each and every Orion Soldier and grateful to all for volunteering to serve our nation, state and communities here in the Guard."

Key training events include infantry security force, live fire, support operations and for the first time a special external evaluation of selected 108th Infantry Soldiers assigned to a terresponse team dubbed ror "CERFP" (pronounced SERF-PEE.) In short, the team will respond to a potential future terrorist attacks in New York where a chemical, biological or radiological weapon has been used. For the last year, Soldiers of the 108th have been intensely training and will be evaluated on 17 June on their ability to conduct Search and Rescue operations in a "hot zone" and decontaminate victims. Following the unit's validation, the CERFP will remain in a ready status over the next year, subject to call up in the event of a state emergency.



New Colors, New Mission SECFOR Battalion Forms Up

The uncasing of the colors for the 2nd Squadron 101st Cavalry took place on June 15, 2007. This event was significant as it identifies the colors associated with a squadron. Uncasing the colors changed the 127th Armor to the 2nd Squadron 101st Cavalry. The 127th Armor was deactivated, and in turn the 2nd Squadron 101st Cavalry is now active.



The 2nd Squadron 101st Cavalry is the lead element for the formation of a Security Forces (SECFOR) Battalion in preparation to support future missions. The mission of the SECFOR Battalion is to provide base security, convoy security and Quick Reaction Force.

Nearly 840 troops from the 2nd Squadron 101st Cavalry, the 1st Battalion 69th Infantry and the 2nd Battalion 108th Infantry have merged together to form the SECFOR Battalion. "The merge is going flawlessly. Soldiers are falling into formation as if they been part of the squadron all along," said LTC Dunkle, SECFOR Battalion Commander.

The SECFOR is up early and ready at 0600 for a full day of training that lasts frequently until 2300 hours. Some of the training that SECFOR has done includes working on tactics, preparing to fire mortars, road marches and physical fitness. "Keys to successful training are maintaining excitement for deployment, effectiveness of squad leaders and overall unit pride."





The First Battalion 258th Field Artillery (Washington Grays) performed live-fire gunnery on June 17, 2007. It has been nearly five years since the 258 FA has fired howitzers as a unit. The unit deployed to *Operation Iraqi Freedom* in 2002 to perform a Military Police mission as part of OIF II. Since returning home, the unit has trained on Warrior Leader Tasks while waiting to receive their equipment. This past weekend, the 258 FA received M102 howitzers that have put them back in action.



According to LTC Paul Conte, the 258 FA Commander, the training with the M102 howitzers went extremely well. Being able to live-fire the howitzers has motivated the troops, and morale is high. "It's rewarding to see an Artillery unit piece itself together with soldiers who have vast and different experiences in conjunction with both old and new equipment, and to see them come together and make the live fire a success," stated LTC Conte.

The M102 howitzers that the 258 FA fired were produced in 1973. They weigh about 3,180 pounds. It takes a 7-man crew to set up the equipment and a 3-man crew to fire. The 3-man crew consists of a gunner, assistant gunner and section chief.




The field artillery is going through a training phase known as the "Reset" or "Repaint Red", for the color of the Field Artillery: RED. Most field artillery units have been deployed as Military Police; therefore, they have not had much training with field artillery equipment. "258 field artillery has essentially reset itself in this fiscal year and continues to focus on reset as new equipment becomes available to the unit," said LTC Conte. Conte went to say, "The school says we want to paint you red…want to make you artillery men again."

The 258 continues to focus on receiving equipment and training for potential missions. "This is step one in a multi year training plan to ready 258 for world wide deployment by 2013," said LTC Conte.

When asked about his experience since taking command of the 258 FA in January, LTC Conte replied, "It's great to be the King of Battle."



Headquarters Company Forges Ahead

Headquarters Company Soldiers, 27th Brigade Combat Team (BCT) continue to validate on individual tasks for the third consecutive week of their Annual Training at Ft. Drum in preparation for potential deployment. It is a requirement that individual tasks be validated before moving on to validate on the collective tasks. Most of the tasks require 85 percent validation. However, there are some tasks such as Call for Fire and HMMWV Rollover that require 100 percent validation in order to move forward to collective training.



According to Captain Sandefur, Headquarters Company Commander, the 27th BCT is the first unit to validate itself. Sandefur went on to say, "In this groundbreaking effort, we are setting the standard for other units to follow or exceed."

The Headquarters Company wraps-up validation training today with an anticipated departure from Ft. Drum on Thursday. Brigade Commander Praises Troops and Leaders for Successful AT

The 27th Brigade Combat Team commander praised his Soldiers, leaders and staff for their extra efforts to make the June Pre-Mobilization training successful. Although the training was not perfect, said Colonel Brian Balfe, the 27th accomplished a lot in a short time. "We have done very well. Task Force Orion and the T & E (42nd Training and Evaluation) battalion have my thanks," he said.



Combined Joint Task Force Phoenix has done very well, he added. "By now, you must have the feeling that what we are about to do is very real," said COL Balfe. "The training you are getting is meant to save your life and the lives of other Soldiers," he stressed. "This mission is important.



Fun Run Marks End of AT 07

Brigade members formed up early this morning for what has now become a tradition to run a 2.5-mile course around the *"Old Post"* of Ft. Drum. For the second year in a row, colors were flying and the call of cadences rang out across the training area. New units were welcomed as the Training Assistance Group (TAG) and Regional Security Assistance Command (RSAC) joined traditional BCT units for this team-building event.



The run marked the end of a three-week Annual Training (AT) period for the BCT that focused on individual skill validation, weapons ranges and establishing a new BCT Staff. The BCT will be back at Ft. Drum for another three weeks of AT in October to continue to hone their "Warrior Skills."



JUNE HISTORY OF THE 27TH IN WW2

This Date in Orion History 14 to 16 June 1944

Northern and Southern Attack forces began preparatory bombardment of the island of Saipan as the 2nd and 4th Marine Divisions and the Army's 27th Division awaited the assault order. The Marines landed the next day and suffered nearly 2,000 casualties along the heavily defended beaches. The 1st and 2nd Battalions of the 27th Division's 165th Infantry Regiment (Fighting 69th) landed during the early morning hours of 16 June and was attached to the 4th Marine Division. The 165th passed through the 3rd Battalion 24th Marines and took up positions in preparation for an attack on the Aslito Airfield.

This Date in Orion History 17-20 June 44

The 258th Field Artillery Regiment saw considerable combat action during WWII even though not assigned with the 27th Infantry Division. Nicknamed the "Washington Grey's," the 258th and its renumbered second battalion - the 991st were among only six units equipped with the 155 mm Gun Motor Carriage M12, a Frenchdesigned gun mounted on the chassis of the M3 Medium Tank. Both units landed in Normandy following D-Day and served in the First U.S. Army, primarily supporting the 2nd and 3rd Armored Divisions. Unit fires proved critical to the breakout operation from the hedgerows and their guns became famous "bunker busters" for point-blank engagements along the Siegfried Line. Battery B became the first U.S. Army artillery unit to shell German soil in September 1944. Both battalions served with distinction through the end of the war.

This Date in Orion History 21-24 June

On 21 June 1944, Saipan's Aslito airfield was open to U.S. fighters hav-

ing been captured by 27th Infantry Division troops during the previous On 22 June, the assault on dav. Saipan's Central Highland began at 0600 when elements of the 2nd and 4th Marine Divisions pushed forward with the 27th in reserve prepared to support either Marine force. That evening, 27th Division troops from the 106th and 165th Infantry (Fighting 69th) Regiments began replacing the Marines' 25th regiment on the line, while the 105th remained in place as reserve at Nafutan Point. The following day 106th and 165th troops cleared the eastern slopes of Mount Topatchau, advancing along the valley road towards the parallel ridge. In the days ahead they would become known as the Valley of Death." and "Purple Heart Ridge."

This Date in Orion History 24-26 June

On 24 June 1944, 27th Infantry Division troops were locked in fierce battle on the Pacific island of Saipan. While Marine units pressed attacks towards the island's capital city of Garapan, the 27th's 106th and 165th Infantry Regiments were confronted with heavily dug in Japanese defenders on difficult terrain that favored the defenders. The 106th could not reduce the stronghold of "Hell's Pocket" and the 165th made no headway against the "Valley of Death," and "Purple Heart Ridge." Furious over the lack of progress, the V Amphibious Corps Commander, Marine Lieutenant General Holland M. Smith relieved the 27th Commanding General, Major General Ralph Smith in what would become a major command controversy that would set back Army-Marine relations for the remainder of the war. The troops on the line did not learn of the relief of their commander until much later.

This Date in Orion History 27-29 June

On the evening of 26 June 1944, the 27th Infantry Division's 165th Infantry Regiment (Fighting 69th) was attached to the 4th Marine Division and re-entered the line on Kagman Peninsula on the Pacific island of Saipan. Also that evening Japanese hold-outs on Nafutan Point managed to infiltrate through the 2nd Battalion 105th Infantry Regiment to attack Marine positions on Hill 500. The Marines wiped them out. Meanwhile, 27th Infantry Division troops continued intense combat operations without knowledge of the relief of their commanding general by Marine Lt. Gen. Holland "Howling Mad" Smith. LTG Smith fired Army MG Ralph Smith for the apparent lack of aggressiveness by 27th troops during the assault on Saipan's central highlands. A board of investigation later determined that the V (pronounced Fifth) Amphibious Corps Commander LTG Smith had the authority to relieve the 27th Division commander but that his rationale was flawed. The lack of Army progress was due to heavier than expected enemy strength at that location. They were fighting from well dug-in positions over terrain that was extremely difficult to traverse. The defenders had the advantage. In addition, LTG Smith had previously ordered the attachment of other 27th infantry units to Marine formations denying the Army assault force the reinforcements needed. "Howling Mad" Smith was known for his cantankerous temperament and criticism for other services. As a result of the Smith versus Smith affair, Marine generals were not placed in command of Army units again during the war. LTG Smith is also known to have spoken disparagingly about the 27th's National Guard status. But MG Smith, who commanded the 27th at the time, was not a New Yorker or even a Guardsman. He was Regular Army and came from Nebraska.

Joseph Rizzo of Holbrook, NY passed away March 7, 2006. He is survived by his wife of 64 years, Angelina, daughter Barbara Francese, husband Rick and his grandsons, Christopher, Michael and Joseph.

Rizzo was proud to be in the Army, which he spoke of his time (5 years) with fond memories of the places and the men he served with.

Marino S. Papalas: was a member of the 27th Division Association passed away on October 26, 2005. He was a Sergeant in the 27th Division, 105th Battalion and served 42 months in the South Pacific Campaign. He was wounded in the invasion of Okinawa, paralyzed from the waist down for over a year. They told him he would never walk again, but he did. The highlight of his recuperation was receiving a bedside visit from Eleanor Roosevelt.
